**This year we have 9 sections, each attracting a prize of \$600.00**

- A) Portraits and people
- B) Abstract, symbolic imagery in any medium
- C) Waterscapes, seas, rivers lakes and more
- D) Landscapes, including country and city
- E) Still Life, structured and unstructured
- F) Fauna, both fur and feather
- G) Miniature and Small Paintings (10cm x 10 cm or 23 cm x 12.5cm prior to framing)
- H) Sculpture, 3D works in any medium
- I) Photography (no larger than A3 size prior to framing)
  - Colour (First \$200.00; Second \$100.00)
  - Black and white (First \$200.00; Second \$100.00)

Local Artist awards are First \$500.00, Second \$300.00 and Third \$200.00

Sections A - H will be judged by Echuca based artist, Glenda Cornell.

Section I Photography will be judged by photographer, Richard Sievers.

**Deniliquin's Easter Art Show Opening marks the beginning of "Deni Fest", a programme of events over Easter, with multiple festivities including the ArtOut Market, concerts in the Park and the Rodeo, which attract many visitors.**

**Proceeds from entry charges and percentages on sales are for community service projects.**

## Conditions of Entry



### ENTRIES

- Applications must be made on the **Official Entry Form** and payment via cheque, postal note or direct deposit details:

- Entries close: 29th March 2019. Remember Australia Post is VERY SLOW, minimum of 8 days delivery to Deniliquin
- Artists may exhibit **up to five works**, suitably framed or ready for hanging
- Each exhibit must have one identifying label, with artists' name, painting title, price, medium and section entered. This should be affixed to the **back lower left corner**.
- All works must be the **original** unaided work of the exhibitor, not previously entered in the Deniliquin Rotary Art Exhibition.
- Each exhibit may be entered for all acquisitive prizes but only one sectional prize.
- **Entry Fees** : \$10 per work less than 1 square metre, \$15.00 for each work more than 1.0 square metre.
- In sections A to F, total area of each exhibit, including the frame, may not exceed 1.2m<sup>2</sup>. In section G Miniatures and Small Paintings and section I Photos refer to page one for sizing.

### DELIVERY AND PACKAGING

- Entries to be **delivered** free of all charges to the Deniliquin Multi Arts Centre, Cressy Street, Deniliquin 2710 on **Tuesday 16th April 2019 between 10.00am and 2.30pm ONLY**. Flags will denote door entry. To arrange earlier deliveries contact Denise at (03) 58812646 (BH)
- Postal entries to be received at the Deniliquin Post Office prior to Friday 12th April 2019. All return address labels and stamps to be included in packaging. Artists are advised to ensure their works are packaged well.
- Unsold exhibits are to be **collected** from the Deniliquin Multi Arts Centre after **2.30pm and before 6.00pm on Monday 22nd April 2019**. The artist or their authorised agent must sign out paintings.
- Insurance for artworks is the sole responsibility of the artist. The committee will exercise all reasonable care in the handling of exhibits, but will not be responsible for any loss, theft or damage of exhibits whilst in its custody.

### SALE & COMMISSIONS

- **All exhibits must be for sale**, and are to remain on display until 12.00pm on Monday, 22nd April, 2019.
- All monies from the sale of entries shall be paid to the Rotary Easter Art Show committee.
- A 25% commission will be deducted from the sale price, with the balance paid direct to the bank account provided or by cheque to the provided address.
- It is the responsibility of the artist to ensure correct documentation if they are GST registered. When setting a sale price take into consideration commission applied and any applicable GST.

### TERMS & PUBLICATION OF WORK

- The entrant permits the Rotary committee to arrange production and publication of the catalogue. The committee shall not be held responsible for any error or mis-description made during the production/publication of the catalogue or other related materials. The committee's records remain the final reference.
- By entering this exhibition entrants agree to their works being photographed for promotional purposes.

### JUDGING

- The three acquisitive prizes will be judged first, and these exhibits will not be eligible for any further prize. The decision of the Judge will be final and no correspondence will be entered into.
- Local Artist Award will be awarded to local artists residing within a 50km radius of Deniliquin, who have not been awarded any other prize. This prize will be selected by Exhibition Judge.

### OPENING NIGHT - AWARD PRESENTATION & VIEWERS CHOICE AWARD

- All winners will be announced and prizes awarded at the Opening Night function.
- Viewers' Choice voting will occur throughout the weekend. The winner will be announced at the conclusion of the exhibition.

### GENERAL

- The Exhibition Committee reserves the right to use its discretion in all matters. Should a dispute arise for which no specific rule is laid down, the committee's decision will be final and no correspondence will be entered into.
- The exhibition committee reserves the right to exclude any exhibit deemed unsuitable for exhibition.
